This Memorandum of Understanding (MoU) is in effect from the date of 11/06/2014 to establish an affiliation by and between **SHAIENDRA EDUCATION SOCIETY'S ARTS, COMMERCE & SCIENCE COLLEGE** established in 1994 & affiliated to the University of Mumbai

AND

MATRUCHHAYA COLLEGE OF COMMERCE AND SCIENCE established in 1993 & affiliated to the University of Mumbai .

WHEREAS Shailendra College and Matruchhaya College have mutual interest in academics , research, cultural and extension activities, substantial advantages may be gained with collaborative and joint beneficial programs which serves to augment intellectual and cultural development in both the institutes. NOW THEREFORE, Shailendra College and Matruchhaya College have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for cooperation between two institutions.

Objectives:

Shailendra College & Matruchhaya College agreed to develop the following collaborative activities in the areas of academic, research, administrative, cultural and extension in accordance with terms and conditions set forth in this MoU.

Under this MoU two Educational Institutions agreed following possible mode of collaboration :

1. Providing information in the field of education , research and other academic activities.. This will help students and staff to share knowledge of mutual interests and facilitate advancement of knowledge on the basis of reciprocating.
2. Helping each other in administrative work for the development of upgrading facilities and smooth functioning .
3. Working in collaboration for smooth functioning of examination process by helping each other in moderation and up gradation of exam system.
4. To organize joint seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein,
5. To provide cultural and intellectual enrichment opportunities for staff and students of both institutes,
7. To help each other in social cause and extension activities of mutual interest.

The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both the educational institutes.

Issues related to traveling and miscellaneous cost are subject to individual negotiation and shall vary according to rules, regulation, policies of each institution. The details for the implementation of this MoU will be worked out on mutually agreeable terms within the policy, rules and regulations of both the institute. Both the parties will not absolve any confidential information during the research activity.

This agreement will take effect from the date of its signing and shall be valid for five Years from that date and may be extended by mutual written agreement. Either party may terminate the agreement at any time during this term by the provision of three months written notice to the other party.
